School Programs Support We managed more than 400 accounts for the homeless education program, service learning projects, special education, outdoor school, literacy mentors, high school career convention, and many other programs relating to art, drama, extracurricular, foreign language, library, math, music, physical education, science, sports, technology, and robotics for 13 schools, 6,295 students and 774 teachers and support staff

4b (Code) (Expenses \$ 22,047 including grants of \$ 21,405) (Revenue \$ 0)

Teacher Support Programs We awarded 30 innovation grants to schools totaling \$18,500 for teachers' projects that enriched and enhanced the educational experience for students in the areas of art, drama, foreign language, library, mathematics, music, physical education, reading, science, social sciences, and writing. Through our Golden Apple Award program, we awarded stipends and grants totaling \$2,700 to honor outstanding teachers and staff in the school district. We also awarded \$205 to help two school district staff members pay for continuing professional education.

Student Success Programs We supported an enriching education for all students. Through our Student Opportunity for Success program, we provided financially needy students with backpacks, clothing, hygiene supplies, field trip and extracurricular activity fees, and test fees for SAT and AP exams totaling \$17,062. Through our scholarship programs, we awarded scholarships totaling \$4,250 to 5 high school seniors to pursue their post-secondary education. During the year we began summer enhancement programs in math, reading and writing to support high school students at risk of not graduating with their classes. We awarded the first \$900 grant for these summer programs at the end of the school year, with the bulk of the grants being awarded during the summer in the next fiscal year.
