Emergency Shelter - Emergency shelter stays for youth (ages 10 - 18) range from a few hours up to 21 days. Important aspects of the emergency shelter program include:

- A safe, stable environment, with 24-hour structured supervision by qualified, caring adults.
- Healthy meals and snacks; personal hygiene products; clothing and shoes, if needed.
- Access to medical care and other essential services.
- A plan to reunite the youth with the family (if appropriate), along with support services such as family mediation.

During FY 2012-13, we served 52 youth in this program, providing 573 bednights.

4b (Code:) (Expenses \$ 110,412 including grants of \$) (Revenue \$ 120)

Transitional Shelter - The Transitional Living Program is for youth ages 15-18 who do not have a suitable home to go back to. Each youth works with trained staff to set goals and create his or her own case plan. Succeeding in school and/or job training are stressed. The program encourages self-sufficiency through the Positive Youth Development approach, giving young people opportunities to exercise leadership, build skills, and get involved in their communities. The shelter provides Independent Living Skills Workshops, tutoring, referrals to employment resources, etc

During FY12-13 we also began working toward establishing a separate Transitional Living shelter for older youth, ages 18 - 20, scheduled to open in the Fall of 2013.

During FY 2012-13, we served 12 youth in this program, providing 666 bednights.

Albany House Start-up / Linn County Outreach Project --

In collaboration with community members and public agencies, JSYSI is working to expand our services in Linn County, and to ultimately open a second overnight shelter facility for youth in Albany, Oregon. Last year we received an important 3-year grant from the federal Family & Youth Services Bureau, and were able to add staff to provide Outreach services to Linn County youth, including youth in rural areas. In September 2012, we opened the Cornerstone Youth Outreach Center (CYOC) in Albany. It serves as an after-school drop-in center, where youth can find resources and assistance. In FY 12-13, 241 youth visited the CYOC.

We continue to build and strengthen relationships with Albany and Linn County partners (County Juvenile & Health Departments local schools, etc) and are working to raise community awareness about the services we offer to youth and families.

Part III. Line 4d: Other program services.

Non-Resident Services (\$53,532) -- Many of these services are intended to assist youth and families with the goal of preventing youth from becoming homeless or running away from their families. Jackson Street operates a 24-hour help line, offering crisis support, information, and referral. Last year 506 callers used this service. Our Outreach program offers individual case-management and assistance to youth who do not require shelter, but need other services. This is Jackson Street's fastest-growing program area, and we served 101 youth during FY 12-13. These 101 youth had 606 total "contacts" with Jackson Street's Outreach staff or volunteers providing services such as tutoring.

Special Programs and Activities (\$28,672) -- As funding allows, shelter staff seek out opportunities to provide social events, educational activities, and classes for current and former clients. An example from FY 12-13 was a six-session activity, "Healing with Horses," done in collaboration with another local agency. Through riding and learning about horses, the program allows youth "to grow in their confidence, self-esteem, and physical strength and awareness." This program area also includes our Youth Advisory Board, which gives current and past clients -- along with other local youth -- the opportunity to use service learning as a way to become more involved in the community.

Yes. After the form was prepared, JSYSI's Business Manager and Treasurer reviewed the full document in detail, then prepared a point-by-point guide to the content of the form and all accompanying schedules. Two weeks before the form was filed, this guide was distributed to all Board Members, together with a copy of the full 990 filing package. Members were encouraged to review the document and to ask for additional information or clarification as needed.

When they join the Board, all new members are given a copy of the Conflict of Interest Policy and they are made aware of its purpose and requirements. Every board member fills out a disclosure form annually. Monitoring compliance with the policy is the responsibility of the board's Executive Committee (President, Vice President, Secretary and Treasurer). The secretary is responsible for maintaining the file of disclosure forms and keeping a list of board members' roles (if any) in local companies that might do business with Jackson Street. The Executive Committee is involved in all significant spending decisions, and can easily check this list to see if potential conflicts of

interest are likely to arise. If there is any indication that this might occur, the board member(s) involved will be asked to update their disclosure form(s) so that the Committee can evaluate potential conflicts of interest.

The Board approved a new Executive Compensation Policy in early 2010, for use in determining compensation for the Executive Director.

The policy embodies all the requirements indicated in question 15 (independence of participants, collection of comparability data, and documentation of the process). The Board's Executive Committee is responsible for collecting the comparability data and any other information needed for the process; the Secretary is responsible for documentation. A review must be done every two years or whenever an increase in compensation of more than 5% is contemplated.
