Seventy-eight used pianos and seven other instruments with fair market values ranging from of \$100 to \$1,000 were donated to the Foundation and subsequently donated to various individuals, schools, and organizations where they will be used to further music education in Oregon. Costs other than grants include personnel costs to manage the program plus the moving company and storage fees to execute the program

4b (Code) (Expenses \$ 45,000 including grants of \$ 20,000) (Revenue \$)

The Foundation conducted a ten grand piano concert in Oregon, which raised funds to support music programs at two local organizations. The support included both program and scholarship funding. \$25,000 of expense consists of production costs allocable to the program aspects of the show, which provides performance opportunities for multiple youth in accordance with the Foundation's mission

The Foundation received contributions from Washington residents, which raised funds to support music programs at thirteen local organizations. Support included program and scholarship funding along with three new pianos
