Stream System and Prairie and Oak Habitat Restoration Program:

Working with stream-side neighborhoods, the Council assesses plans, prioritizes and implements projects to improve wildlife habitat, water quality and watershed function. Our current emphasis is on four tributary systems within the Marys River watershed - TumTum River, Woods, Greasy and Beaver creeks.

During FY 2012-13, we worked with seven landowners along .87 miles of upper Greasy Creek and Wells Creek to remove 6 fish passage barriers and place large wood in the stream channel to improve channel function and fish

Outdoor Classroom Program:

The Council partners with schools and other non-profits to offer hands-on outdoor learning opportunities in the context of stream and prairie restoration projects across the watershed. The Council provided on-the-ground riparian restoration experiences and field days to 350 middle and high school students in partnership with local public and private schools. More than 135 parents and community volunteers assisted with these events.
