Five Wellness Centers are located in Alameda, Pleasanton and Fremont. Wellness Centers provide services to over 300 clients. Funds are provided by Alameda County Behavioral Health Care, the Cities of Alameda, Fremont, Hayward, Union City, Dublin and donations

Crisis Residential Program - Community based mental health program, an alternative to hospitalization. Provides 12 beds for individuals between ages 18-59. Woodroge Place is open 24/7 and provided 3,411 client days to over 225 Alameda County residents. The program also provided 564 hours of medication support. Funded by Alameda County Behavioral Health care

Case Management/Supported Independent Living - Maintains shared housing in cities of Hayward, Livermore and Pleasanton. For adults with moderate level of independence. Case Management provided 5,165 hours of mental health case management and mental health services and 7136 hours of medication support.
