In close alignment with the Hospital's strategic plan, the Foundation raises funds to support specific equipment, capital needs, projects and programs at Sequoia Hospital or to fund greatest needs at the Hospital. When specific needs are identified, the Foundation invites grant requests from the Hospital for equipment and programs to enhance patient care. Grants requests are considered carefully by the Finance/Grants Committee and when accepted, these are recommended for approval by the full Foundation Board of Directors. Before grant funds are paid to the Hospital, Foundation staff personally confirms that relevant items have been received. Grant disbursements are then made based on copies of invoices received from the hospital's finance, materials management and/or accounts payable departments. Sequoia Hospital Foundation supports the Sequoia Hospital/San Francisco State University Bachelor of Science (BSN) in Nursing Satellite Program at Caada College through scholarships to students funded by generous donors. The program was founded by and receives continuing support from a unique coalition of community partners including Sequoia Hospital, the Sequoia Healthcare District, San Francisco State University (SFSU) and Caada College. Scholarships are awarded by the 6-8 member Scholarship Committee after a rigorous application and interview process overseen by the Foundation's Board of directors and in close collaboration with the financial aid office at San Francisco State University. Scholarship awards are made only when SFSU has confirmed that the students are in good standing and registered for the required classes in the program. Occasionally, the Foundation awards small grants to community partners who collaborate with Sequoia Hospital for specific health, wellness and outreach programs. All such grants are made from donor funds restricted to these projects and with the approval of the Foundation's President as required by policy. Use of the funds is verified with each community partner.
