The ASE Near Earth Objects Committee continued its engagement with the United Nations Committee on Peaceful Uses of Outer Space and its Scientific and Technical Subcommittee to develop the recommendations submitted to the UN by the NEO Committee in 2009. The report recommended creation of an asteroid detection and warning network, a group to plan deflection missions, and an international group to oversee any needed deflection campaigns. In 2013, the UN adopted some of the ASE recommendations and approved an International Asteroid Warning Network to share information on hazardous asteroid detections and impact predictions, a Space Missions Planning Advisory group to undertake joint studies of NEO deflection mission options, mission costs, and needed technologies, and a role for the UN COPUOS to consider and authorize any necessary NEO deflection campaigns.

In 2013 ASE-USA initiated a scholarship program for undergraduate students and developed its first scholarship at the University of Alabama-Huntsville.

International, Foreign Affairs & National Security. Ninety-four astronauts, cosmonauts and taikonauts from 17 countries convened in Riyadh, Saudi Arabia, in September 2012 for the XXV Planetary Congress of the Association of Space Explorers. Hosted by ASE Founding member HRH Prince Sultan bin Salman al-Saud, the theme of the XXV Congress was "Space Technology for a Knowledge-Based Society." Attending astronauts and cosmonauts made over 20 technical presentations over 2 days at universities and technical institutes across the Kingdom of Saudi Arabia.

Windows on Earth. ASE and its partner TERC (Technical Education Research Center) completed development of the Windows on Earth software project, which was launched to the International Space Station in May, 2013 and currently supports astronaut Earth photography. ASE and TERC are developing Citizen Science and other educational components of the software, using the imagery downloaded from the space station. ASE received \$30,000 from the project as part of our agreement with TERC to support this project.
