When in Armenia, the President lives in a University-owned apartment on campus which is used substantially to conduct business. Since the University has its presence both in Armenia and in the U S , frequent travel to Armenia and back to the U S is a business necessity. Therefore, as part of the President's contract, AUAC pays for the President and, on occasion, his family to travel to and from Armenia for work directly related to his position as President in accordance with the established policies.
