**Sister Rising Employment Training Program:**

In addition to Educational support service and Case Management we also lead and graduated another cycle of Sister Rising youth Organizers. In the midst of transitioning old staff out and new staff in during their cycle, the young women stayed engaged and motivated to complete the program. Their end goal was to leave the program entering college, a vocational program, or finding other employment. The young women grew a strong bond and had the opportunity to sit at the table with Mayor Edmund Lee to discuss the inequities of young women who have been impacted by multiple risk factors, foster care system, who have had multiple arrests, not successful on their own or who are two or more grades behind in school. They discussed the trials of young women coming out of detention having a limited educational background and the stigma of a criminal record, making their future options for college and job prospects. Out of that meeting they asked the Mayor to ensure that young women and girls are prioritized for job opportunities in San Francisco.

It is fascinating and inspiring to see these young women grow in such a short period. In the past nine months, three young women of the seventeen that were hired did not complete the program due to previous cases that sadly did not fall to their favor. At CYWD we see the potential that these young women hold and have asked them to come back to complete the program in the next cycle. We want to ensure that these young women know we will not turn our backs on them and we will support them to become employable and college ready.

As of June 30, 2013, fourteen of seventeen Sisters Rising participants completed the Sisters Rising Training Program. Each participant who completed the program worked on

their transitions plans, which they presented at the Sisters Rising Graduation. After the end of the internship, the young women have various plans that they have lined up for the summer and for their future. These plans consist of enrolling in community college, modeling academy, DCYF Youth Warrior, medical assistant programs, summer jobs, and training to become a Certified California peer counselor.

Young Mothers United/Leadership Development program:

We had three cycles of "Women at the Forefront" and two cycles of "Parenting Class". We graduated a total of 10 young women in our 12-week policy training and 13 in the parenting class. Most young women go from parenting classes to policy training where they experience lobbying for the first time then to the Sisters Rising program where they learn soft and hard skills to become community organizers while working on their healing and personal development. When we ask young women to talk about their experience at CYWD we often hear about the Sisterhood/Community that has been built and how they went to Sacramento to make change. CYWD believes that the best change-makers are the ones directly impacted by the conditions that need to be changed.

We completed the Policy Platform which was designed to deepen community understanding of the Center for Young Women's Development's (CYWD) framework and theory of change. Its use enables us to support policy engagement with strategy and alignment to the organizations core values and constituency-society's most marginalized young women. We prioritize policy strategies that address increasing access to comprehensive reproductive health, economic self-sufficiency, and wellbeing of the young women we serve. Young women of color, young mothers, young queer women, formerly incarcerated young women, and undocumented young women are the core of our constituency. The next step is to develop a year-to-year agenda that

Further, YMU members planned and completed their annual Know Justice conference that brought in over 300 youth participants from across the great Bay Area. This has been the largest group of participants CYWD has seen. This year Mamas Day happened in June. We held a Mamas Day lunch and booth at SF PRIDE. The goal was to do membership recruitment and shift culture on what a Strong family looks like. Our allies from Forward Together have been instrumental in helping us achieve this goal. The Mamas Day card, stickers and posters have been a great hit on the inside.
