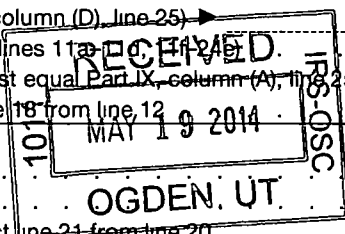

Services include initial and ongoing resettlement, immigration legal services, family support and child abuse prevention, specialized support for seniors, and assistance with navigating health care and other systems of care. Mental health services include individual, family, and group therapy sometimes addressing post-traumatic stress issues due to war and relocation

Parenting & Youth Services - provides mental health services for underserved children and their families, including home-based intervention and ongoing case management for children ages 0-7. Provides mental health consultation, services to numerous preschool sites, helping teachers, administrators, and parents to effectively assist children and their families. The agency's early childhood staff has expertise in responding to children exposed to domestic and community violence, trauma, and neglect. The agency also provides training to those providing mental health services to elementary, middle and high school students

Adult Services - provides resources and support to adults and their families, including case management, counseling, family intervention, support groups and educational workshops. Also provides specialized services to Holocaust survivors. Adult Services works with older adults and their family members to preserve independence and allow people to age with dignity in their own homes. Counseling Services provides a broad range of mental health and other supportive services to adults, children and families, including specialized support for people with developmental disabilities and those dealing with bereavement.
