In Fiscal Year 2013, the Organization wrapped up its collaboration with the Ministry and USAID, supplying 5000 books, library furniture, and training at one of the most remote of the Ministrys TLMP program, in Logiya in the Afar region The Organization also began the process of assessing and strengthening existing libraries both in Addis Ababa and the southern region around Awassa, continued services at the childrens community reading center in Awassa, and offered expanded classroom-and-library-based activities meant to mentor teachers and librarians in good reading instruction practice The Awassa Reading Center moved in December 2012 into a new facility Fiscal Year 2013 saw two schools built in the villages of Azedebo and Fundame, villages not far from the city Durame These facilities are kindergartens and early-grades libraries, serving existing primary school communities The kindergartens serve more than 200 children each Fiscal Year 2013 also saw the resurrection of Ethiopia Reads deep rural mobile library outreach, called Horse-Powered Literacy, in the regions near Chancho in Oromiya and near Kololo in Kembata-Tembaro Professional Development continued among librarians and teachers, including a major training in Addis Ababa in the fall of 2012, and including a year-long support group for library managers An Organization-sponsored assessment of school libraries was conducted by Dr Alicia Van Borssum in December 2012, and from that foundation, a planning process began for an ambitious pilot of onsite training to begin in 2014 Volunteers continued to collect books and fundraise to send a container of English-language books to support the childrens library collections A great deal of time and work was put into reorganizing and improving organization structures both in the US and in Ethiopia
