DURING THE FISCAL YEAR 2012-2013 OUR MENTORING PARTNERSHIP INCLUDED CHILDREN'S HOSPITAL OF LOS ANGELES, HBO, MTV, PARAMOUNT, RHINO ENTERTAINMENT, AND URBAN OASIS FILM ACADEMY. FOR EACH PROGRAM YMC PROVIDES A COMBINATION OF MENTOR AND MENTEE RECRUITMENT, SCREENING, TRAINING, AND ONGOING SUPPORT; FACILITATES GROUP AND ONE ON ONE MENTORING ACTIVITIES; AND PROVIDES CASE MANAGEMENT FOR YOUTH WHERE NECESSARY.
