

to serve as positive role models, educators and advocates of social justice.
VE Global annually recruits, selects and trains between 25-30 volunteers
from around the world to provide volunteer support to children's homes,
community centers and educational establishments located in Santiago, Chile.
Volunteers create and implement innovative educational and recreational
programming for children and youth at social risk. VE has 5 main projects:

- 1) Vamos a Leer: Summer motivational and educational reading program
- 2) Liga de Deportes: Monthly health and wellness sports league
- 3) Festival de Arte: Biannual art and performance exhibition and art workshops
- 4) English in Motion: English language learning workshops during school year
- 5) Original Volunteer Workshops: Volunteers plan and execute a variety of original workshops with children and youth to support social and emotional learning.

VE Global volunteers work full-time in Chile for a minimum of four months with the goal of successfully integrating into VE partner organizations as extra human resources to support the children and youth. VE requires this considerable commitment to ensure that continued cycles of abandonment are avoided.

Line 28, Expenses/Grants (\$48,444), Program Service Accomplishments

VE Global grants funds to VE Global Chile to support the selection, training and ongoing in-country support of international volunteers in Santiago, Chile. Selected volunteers commit to a minimum 4-month, full-time volunteer work experience and provide approximately 35,000 to 40,000 hours of donated in-kind service every year.

VE Global Chile partners with 4 residential group homes for children removed from their families by the Chilean family services and court system, in addition to a number of community centers and a school for children with special needs. Through their volunteer work and commitment, VE provides direct educational and recreational support to over 250 children in its network of Chilean partner organizations dedicated to child welfare.
