THE MISSION OF THIS PROGRAM IS TO CHANGE THE TRAJECTORY OF DISADVANTAGED YOUTH RESIDING IN THE OVER-THE-RHINE COMMUNITY BY HELPING THEM REACH THEIR FULL ACADEMIC AND ATHLETIC POTENTIAL. URBAN SQUASH IS A NATIONALLY TESTED YOUTH DEVELOPMENT PROGRAM OVERSEEN BY THE NATIONAL URBAN SQUASH ASSOCIATION. THE PROGRAM COMBINES ACADEMICS, MENTORING, FITNESS, COMMUNITY SERVICE, CULTURAL ENRICHMENT, AND COLLEGE PLACEMENT FOR STUDENTS IN THE OVER-THE-RHINE COMMUNITY.
