Our YMCA programs, such as Child Care for 0 to 12 years of age, Pre-school, Child Watch, Youth Sports and Swimming, offer a range of experiences that enrich cognitive, social, physical, and emotional growth. Expenses include subsidies and direct financial assistance that make participation possible for 17 percent of the young people we engage.
