Our three largest activities include providing resources, programs, and outreach to protect and improve the lives of cats (humane care and outreach), advocating for and supporting policies that are in the best interest of cats (law and policy), and increasing understanding of cats (education and awareness).

Humane Care and OutreachHillsborough County, FloridaIn April, Alley Cat Allies, Inc. rallied our supporters in Hillsborough County, Florida to urge their commissioners to support a new program that would save 4,000 cats' lives. They responded enthusiastically. As a result, County Commissioners endorsed the two-year Community Cat Pilot Program with a 6-1 vote. The program will redirect 2,000 community cats each year from the county shelter, where they almost certainly would be killed, to Trap-Neuter-Return (TNR) programs across the county. North Ridgeville, OhioWhen Alley Cat Allies, Inc. heard that a humane officer in North Ridgeville, Ohio shot five kittens in June, we immediately launched a petition drive that collected more than 31,000 signatures. Our constituents' support also made it possible for us to attend a City Council meeting in support of local efforts to change policy in the region. As a result of our work and the international outcry over the shooting, the city announced that it will no longer catch and kill cats. Instead, residents who call about outdoor cats will be directed to local animal protection organizations. PennsylvaniaAfter one cat tested positive for rabies, officials in South Newton Township, Pennsylvania announced they would hire a trapper to round up and kill all cats who were outdoors on the 7th and 8th of September. Alley Cat Allies, Inc. helped put so much pressure on township officials that they decided to abandon their plan. We then sponsored a free vaccination clinic for all local cats and dogs in September instead. Also in Pennsylvania, Radnor Township commissioners unanimously passed a mid-August resolution supporting Trap-Neuter-Return as the most effective way to reduce the outdoor cat population. Radnor also abandoned language that would have legally defined caregivers as owners of feral cats after Alley Cat Allies, Inc. and others expressed strong opposition. Feral Friends NetworkMembers of our Feral Friends Network are our on-the-ground allies providing people with local Trap-Neuter-Return and spay/neuter expertise. The network is a group of organizations, individuals, and veterinary practices who can provide guidance, knowledge, and services to help a person new to feral cats and their care. Launched soon after we formed, the Feral Friends Network has helped tens of thousands of individuals over the years obtain the resources they need to start organized TNR programs in their own communities. In 2013, the network grew by 29.99%. 1,565 members of the network helped advocates, caregivers, and interested individuals new to the movement by providing their feral cat expertise and services. Thanks to our members in all 50 states (and Washington, DC) and 21 countries.

Education and AwarenessEffectiveness & Growth of TNR NationwideA landmark report was released this spring by Alley Cat Allies, Inc.'s legal team documenting an incredible ten-fold increase over the past decade in the counties and municipalities that now support Trap-Neuter-Return, from just 23 in 2003 to more than 350 this year. States and major municipalities that have adopted TNR to date include Illinois, Utah, New York City, San Francisco, Philadelphia, Chicago, Indianapolis, and the District of Columbia, setting the stage for more to follow. Common Sense for Cats In May, Alley Cat Allies, Inc. delivered a petition to the Smithsonian Institution signed by more than 55,000 of our supporters in protest of a controversial study that falsely blames cats for declining bird species populations. We launched a bold new website, Common Sense for Cats.com, which explains the massive failure of catch-and-kill and debunks the misinformation that plagues many media stories about outdoor cats. National Conference Architects of Change for CatsOn November 8-10, 2013, Alley Cat Allies, Inc. hosted its first major national conference in Arlington, Virginia near Washington, DC. More than 350 caregivers, shelter staff, representatives from animal control agencies, veterinarians, and other advocates representing 37 states and one foreign country (Israel) attended. There were more than 20 expert speakers who shared successful blueprints of change for cats. This conference was so important because we have now reached a tipping point in our movement to keep communities safe for cats. The number of municipalities that support Trap-Neuter-Return has increased tenfold in the last decade alone. This conference enabled us to keep the momentum going so that attendees went home recharged and ready to make change in their own communities. National Feral Cat Day 2012 and 2013On October 16, 2012 and 2013, Alley Cat Allies, Inc. hosted our 12th and 13th annual National Feral Cat Day, respectively. Participation reached a historical high with more than 430 individuals and groups which held events in all 50 states as well as various international countries. Countless cat lovers wrote about National Feral Cat Day on social media, four counties issued proclamations recognizing the day, and we had letters to the editor and articles in newspapers across the country. We also modified our National Feral Cat Day Awards Program and offered awards to five shelters if they agreed to stop accepting feral cats and support TNR. The shelters that win the cash awards will receive ample support and guidance from our staff as they transition from killing feral cats to helping these community cats thrive in their outdoor homes. Helping Cats in Your Community WebinarAlley Cat Allies, Inc. continues to hold Webinars for caregivers all over the country. The webinars are held monthly with 30 to 40 attendees from all around the country, including professionals from the veterinary field, animal control officers, and caregivers learning the life-saving basics of TNR.

Law and PolicyFloridaIn March, Alley Cat Allies, Inc. began advocating for a bill supporting animal shelter transparency in Florida. It worked, and Governor Rick Scott signed the bill. This means that all animal agencies in the state that accept public funding must now report the number of animals they adopt, transfer to rescue groups, Trap-Neuter-Return, and kill. The new law also confirms that Trap-Neuter-Return (TNR) is unequivocally legal in Florida. Pompano Beach, FloridaAt the request of the mayor, a remarkable move in itself, Alley Cat Allies, Inc. presented a proposal for a Trap-Neuter-Return program at the Pompano Beach City Commission meeting in July. New policies for TNR haven't yet been implemented, but the process is moving forward. The City Animal Control Division has been asked to sit down with advocates to try to reach a compromise, and the city's staff will review TNR policies in other Florida jurisdictions. Alley Cat Allies, Inc. will stay engaged in Pompano Beach as the city moves to adopt better policies for cats. Arlington, TexasIn mid-August, Arlington City Council members unanimously adopted one of the strongest TNR policies in Texas. Alley Cat Allies, Inc. was able to work side by side with officials to develop the resolution, which will now serve as a successful model for our efforts in other parts of the state. Arlington City reported a 67% save rate for cats in September 2013 compared to 37% in 2012.
