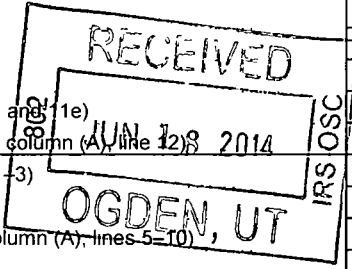

Every Orphan's Hope mission is to plead the cause of orphaned children in the world, unite the Christian Church to care and provide for these children, and to bring social relief through specific programs designed to accomplish these purposes through the sharing of the Gospel of Jesus Christ. During 2012, short-term mission volunteers hosted Camp Hope events for 684 orphaned children serving 6,840 meals with 450 making professions of faith in Christ. The organization provided 40,000 meals to children who attended a 10th anniversary Orphan Sunday event. The organization also supports 11 orphan homes with 88 children and 11 widows.
