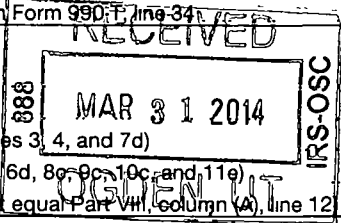

AZ Academy's academic day program served 84 students for the 2012-2013 school year. With a staff and student attrition rate of 80% the school continued to grow and become more unified. The Common Core State Standards were adopted by the school, with implementation beginning in 2013-2014 .New Curriculum maps were in development. Students continue to show growth as a result of a greater focus on standards-based instruction.

Az Academy was awarded a 21st Century Community Learning Center grant in the spring of 2011 . This grant provides for an after school program for 3th and 8th grade public and private school students. The focus is to improve reading and mathematics skills, to foster positive behavior , and to develop healthy lifestyles.
