SOURCES OF REVENUE ARE \$20,000 FROM THE ANNUAL CAMPAIGN, AND THE NET PROCEEDS OF THE DISTINGUISHED SPEAKER LUNCHEON WHICH TOTALLED \$353,212. THE PARENTS ASSOCIATION HAS EXPENSES FOR THE FOLLOWING: ORGANIZING THE PARENT SCHOOL COFFEE AT THE BEGINNING OF THE YEAR, PROVIDING THE TEACHER APPRECIATION LUNCHEONS, PURCHASING COFFEE FOR THE SCHOOL WORKROOMS, TEACHER CHRISTMAS BONUSES, SALARY INCREASES, AND PRINTING THE SCHOOL DIRECTORY. IN ADDITION, IT IS THE UMBRELLA ORGANIZATION THAT HOUSES ALL PARENT VOLUNTEERS.

REVENUES TOTALLED \$175,217 AND CAME PRIMARILY FROM THE FOLLOWING AREAS: MEMBERSHIPS, CONCESSIONS, MERCHANDISE, HOMECOMING, SPRING SWING, FLIGHT NIGHT, YARD SIGNS. NET INCOME OVER EXPENSES WAS GRANTED TO THE SCHOOL ATHLETIC DEPARTMENT TO PAY FOR UNIFORMS, EQUIPMENT, AND PLAY-OFF EXPENSES.
