



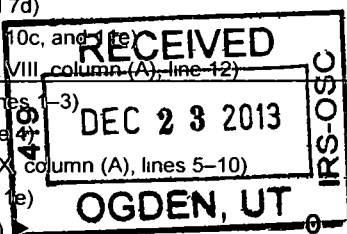

- 5) The FAC reviews the application. The following factors for granting Children's Fund money to a family include:
 - School Administrator support of applicant enrollment
 - Family is non-native
 - English is not the primary language spoken at home
 - Family lives within community/David Douglas school district
 - Family exhibits desire to participate in HMS community, knowledge of benefits of early childhood education
 - Family willing to accept responsibility for annual partial tuition payment (.05% to 1%)
 - Availability of funds for three year enrollment
- 6) If application meets above criteria for becoming Children's Fund recipient and funds are available, recommendation to accept is made by FAC and submitted to Administrator.
- 7) If application does not meet above criteria or funds are not available, recommendation is made to reject application and submitted to Administrator.
- 8) Administrator may appeal to Executive Committee if unsatisfactory recommendation is made by FAC.
- 9) Applicant is notified of acceptance or rejection.
- 11) All CF families are expected to fulfill the requirements of the standard Share Hours contract.
