## RESTATED ARTICLES OF INCORPORATION

The undersigned certify that:

1. They are the **president** and the **secretary**, respectively, of CALIFORNIA FARM BUREAU SCHOLARSHIP FOUNDATION.
2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

### ARTICLE I

The name of this corporation is CALIFORNIA FARM BUREAU SCHOLARSHIP FOUNDATION.

### ARTICLE II

- a. This corporation is a nonprofit **Public Benefit Corporation** and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- b. The specific and primary purposes for which this corporation is formed are:
  1. To establish and maintain on a nonprofit basis a permanent fund to be used for furthering the educational opportunities of deserving young people.
  2. To encourage and promote the education of deserving young people by providing financial aid and other assistance.
  3. To take gifts of real and personal property and to receive bequests and devises by will for its own use or upon trusts to the same extent as a natural person.

c. Other purposes for which this corporation is formed are:

1. To receive, take title to, hold, contract for, purchase, construct, build, furnish, operate and maintain suitable buildings or improvements upon any real property acquired by this corporation as may be needful or convenient for any of the purposes herein specified or referred to, and to rent to others any building or improvement belonging to or under the control and in the possession of this corporation in order to carry out any of the herein mentioned purposes and in conformity therewith; to borrow money and grant security therefor, and to generally render services or receive, purchase, acquire, lease, hold, mortgage, lien, sell and otherwise deal in and with all and every kind of personal or real property for the uses and purposes of the corporation, and to apply the proceeds of any services, sale or rental, including any and all income, to the uses and purposes of the corporation.
2. To do and perform any and all acts and things necessary, proper, convenient or desirable for and to effect the full and complete exercise and enjoyment of any and all of the powers and purposes of the corporation hereby created.

### ARTICLE III

The number and tenure of office of the directors and their powers and duties shall be set forth in the bylaws. Directors shall be chosen by California Farm Bureau Federation, and this provision as to the manner of choosing directors shall not be amended or repealed except by the unanimous vote or written consent of the members.


### ARTICLE IV


- a. This corporation is organized and operated exclusively for and will carry on exclusively charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.
- b. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- c. The property of this corporation is irrevocably dedicated to charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

- d. Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation that is organized and operated exclusively for charitable purposes and that has established its tax-exempt status under section 501(c)(3) of the Internal Revenue Code.
3. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the required vote of the members.
