Understanding Disabilities, Inc. provides disability awareness programming to students in the Reading schools. UD helps children to see beyond people's disabilities, and view other children as individuals and friends. UD's message of understanding encourages respect for the abilities of those with disabilities.

PART III, LINE 28

Eight specific disability-awareness educational programs were provided to all elementary and middle school students, totaling about 2400, in the Reading public schools. With 200 trained volunteers, our curriculum provides information, steers children through activities, and introduces them to people with disabilities. Parents and teachers report a result of increased understanding and respect for the abilities and challenges of people with disabilities, and a classroom environment more accepting of differences. UD units teach about Physical Disabilities, Hearing Impairment, Visual Impairment, Learning Disabilities, Developmental Disabilities, the Autism Spectrum, and about Food Allergies.
