THE COST FOR EACH INDIVIDUAL MEMBER IS \$40 PER YEAR. FUNDS COLLECTED PROVIDE GENERAL OPERATING REVENUE TO THE ORGANIZATION. THE ORGANIZATION CONDUCTS A CONFERENCE EACH YEAR FOR ITS ENTIRE MEMBERSHIP. 161 PEOPLE ATTENDED THE 2013 CONFERENCE. THE LOCATION MOVES AROUND THE STATE TO ENABLE CONVENIENT ATTENDANCE BY ALL PROFESSIONALS IN THE FIELD.
