Beginning September 1, 2013, PVES transformed from a Houston Independent School District External Charter School to an Open Enrollment Charter School reporting directly to the Texas Education Agency. This recent development provides additional autonomy in regards to (but not limited to): school management, enrollment, geographic boundaries, and it also replaces previous local resources with state and federal resources. One of the most prominent aspects of this transformation is that Pro-Vision now accepts young ladies in addition to young men. During the 2012-13 school year, PVES graduated its first high school class. PVES educational paradigm emphasizes structure and classroom management in the educational process believing that students must first have a safe and structured environment before any learning can occur. PVES then blends meaningful relationships with responsible adults, personal accountability and innovative educational techniques with traditional school curriculum.
