The names of the nominees shall be submitted in writing by the secretary of the corporation at least ten (10) days prior to the date of the Board of Directors meeting. Members can only be elected by a majority vote of the Board of Directors. The Executive Committee will be charged with responsibilities dealing with personnel. These will be: A To develop a policy and procedure for staff salaries. B To implement a staff evaluation with the approval of the Board of Directors. The staff will be formally evaluated annually by the personnel committee and their supervisors. C To update personnel policies and job descriptions annually. D To interview and make recommendations to the Board of Directors of any designated staff hiring. E To mediate any disputes between staff members and supervisors. F To ensure the continuation of an ongoing evaluation of staff, the personnel committee will meet on a quarterly basis.
