Learning Connections - focuses on preventing severe academic difficulties or school failure by providing intensive reading, writing and math instruction for low-income children and youth, resources for classroom teachers, and support for their parents In FY2013, the Learning Connections program enrolled 631 children, 65% of students improved their academic skills as measured on pre and post-tests Additionally, the Parents as Partners program, which complements the Learning Connections program, aims to increase parental involvement in literacy and served 358 parents and children, 99% of parents gained useful information and strategies to support their children's academic success
