This past year, the Foundation again awarded 5 high school students high-end digital cameras (worth \$779.99 each) and awarded \$2,500 scholarships to 6 college students (payable to their school). Last year, the Foundation also provided a \$1,000 grant to the Daniel Pearl Magnet High School in Van Nuys, California to purchase camera equipment. The Foundation also funded its second annual internship program at Jim Cox's former TV Station, KTVK-3TV. We funded the cost of compensation to the intern and the company's matching taxes (\$1,113.37). In the past, the Foundation has also purchased an editing bay (\$10,000) at Arizona State University, purchased high-end cameras for Huntington High School, New York, purchased recording equipment for Hopi High School in Keams Canyon, Arizona, and purchased or given gently used camera equipment to the George Washington Carver Museum in Austin, Texas and the Duke Ellington School of the Arts in Washington, D.C., and the SEED Public Charter School in Washington, D.C.
