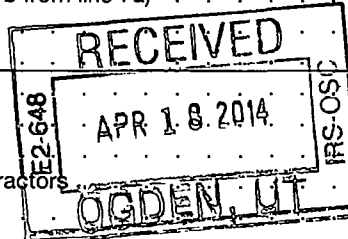

The adjustment of 1,102 was necessary to get the calculations right for the ending balance of 2012. There was a transition of bookkeepers in 2013 (prior to the completion of the 2012 return) and there were some reconciliations required to "clean up" the books going forward.
