During the fiscal year, the Endowment Fund supported the construction and purchase of medical equipment of the Chincha Medical and Educational Center in Chincha, Peru, which had been devastated by an earthquake in 2008 The Center began treating patients during 2011 but was not self-sufficient and needed funds for the first year of operations The Endowment Fund also sponsored medical missions in Contamana, Iquitos, Yantalo, Ayacucho, Chorrillos, Collique, Cusco, Huancavelica, Pisco and Santiago de Chuco During these missions, indigent patients were treated free of charge as the physicians and nurses volunteered their services Funds were raised by sending promotional materials to the membership of the Peruvian American Medical Society to help the Chincha Medical Center, the various missions and expenses in Peru and in the USA The Auxiliary collects funds to help childrens units in hospitals and orphanages The San Fernando Fund focuses on helping the San Fernando Medical School in Lima by providing computers, teaching programs online and sponsoring medical scholarships
