or ratify the arrangement/transaction based solely on whether it is in the best interest of the

Stanley-University of Iowa Support Organization in performing its mission. The authorization,

approval, or ratification must be accomplished by an affirmative vote, as applicable, of a

majority of the Directors on the Board who have no direct or indirect interest in the

arrangement/transaction. The authorization, approval, or ratification may not be made by a

single director.
