ARTICLE I

The name of the corporation is Cleveland University – Kansas City.

ARTICLE II

This corporation is organized exclusively for charitable, scientific and educational purposes. The terms charitable, scientific and educational shall have the same meaning herein that they have in Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended.

Without limiting the generality of the foregoing, the purposes of this corporation shall include the following:

(a) To establish, support, maintain and operate an institution or institutions of learning for education and instruction in (i) the art, science and philosophy of Chiropractic and the providing of instruction in all subjects relating to and bearing upon the proficiency of that profession and (ii) such other professional or post secondary educational courses in which a professional, undergraduate or post graduate degree can be obtained;

(b) To promote and encourage education and the teaching and the practice of the science of Chiropractic and such other professional or post secondary educational courses and to issue diplomas and confer degrees with respect thereto;

(c) To establish, maintain, support and operate libraries, laboratories, clinics, and all other facilities which may be used solely to further the educational purposes of the corporation;

(d) To erect, own or lease land and improvements thereon, and to own or lease books, equipment and any other personal property useful or appropriate in connection with operating educational institutions;

(e) To maintain faculties of educators and researchers and a staff of personnel to operate educational institutions and related activities; and

(f) To support and conduct any activities connected with the operation of educational institutions and any educational or cultural activities in any manner related thereto;

Provided, however, that notwithstanding the foregoing enumeration of particular purposes found in this paragraph, this corporation shall not engage in any activity which may not be engaged in by a corporation which is exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the comparable provisions of the Internal Revenue Code then in effect.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. The corporation shall not, directly or indirectly, participate in, or intervene (including the publishing or distributing of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

No part of the net earnings or other assets of the corporation shall inure to the benefit of any trustee, officer, contributor, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in these Articles of Incorporation.

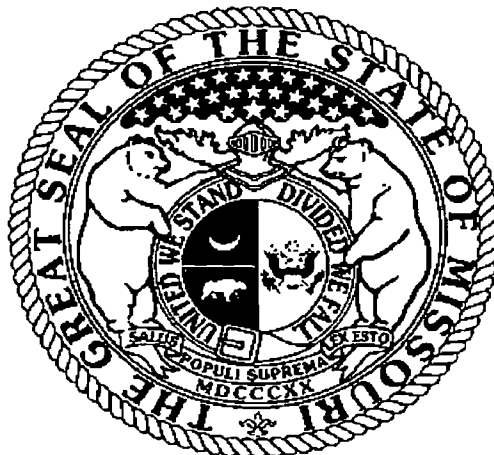
