KNDR's service area is an 80 mile radius of Mandan, ND with three 30 mile radius translators in Beulah, ND, Firesteel and Mobridge, SD. KNDR is a 24-hour continuous broadcasting station. Christian music makes up approximately 75% of the listening schedule. KNDR also has a strong commitment to Bible teaching and faith-based talk programs reinforcing the message in the music which makes up the remaining 25% of the schedule. The station is an active participant in the North Dakota State Emergency Alert System. The station endeavors to reflect family-friendly events and community resources in our listening area on our website and makes the airwaves available to local public service announcements and interviews.
