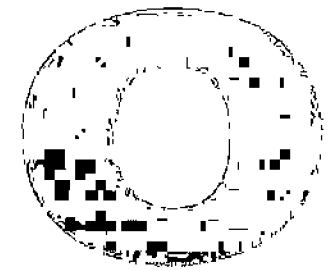

OSSA works to keep you on the snow

The Oregon State Snowmobile Association is an organization of individuals, local snowmobile clubs and businesses interested in **protecting and enhancing** the sport of snowmobiling.

promotes the proper recreational uses of snowmobiles on the land in keeping with the protection, preservation and enhancement of all natural and environmental resources. Oversees the safety certification program for the state of Oregon.

provides representation at every phase of Oregon's public lands useage.

keeps members informed of state and national issues important to snowmobiling.

represents snowmobilers as an organized group.

provides snowmobilers with a way to meet other winter recreationists in an atmosphere of cooperation.

assists state and local law enforcement agencies in winter search and rescue efforts

works with state and government agencies (USFS & BLM) to develop and maintain a quality snowmobile trail system and series of maintained parking lots.

The state association, in conjunction with the 24 grooming clubs and the help of a few private contractors, grooms more than 31,000 miles of trail. This is made possible with funds from the return of gas tax, license fees and more than 25,000 hours of volunteer labor from the various snowmobile clubs in the state.

provides representation at Legislature, both on state and national levels.

The state association has a Legal Action Committee to call on when legislative problems arise throughout the state.

- I will respect the rights of all other snow-users who enjoy the beauty of the outdoors.
- I will respect public and private property
- I will park considerately, in the sno-park taking no more space than needed, without blocking other vehicles and without impeding access to trails
- I will keep to the right of the trails when meeting another recreationist.
- I will yield the right-of-way to traffic moving downhill.
- I will slow down and use caution when approaching or overtaking another.
- I will use the proper hand signals whenever necessary to indicate my direction of travel.
- I will respect designated areas, trail-use signs and established trails.
- When stopping, I will not block the trail, but stop as close as possible to the right hand side.
- I will not disturb wildlife.
- I will avoid areas posted for the protection or feeding of wildlife.
- I will not interfere with or harass others.
- I will volunteer assistance in the case of an emergency.

• I realize that my destination objective and travel speed should be determined by my equipment, ability, the terrain, weather and the traffic on the trail

• I will pack out everything I packed in and will not litter.

• I recognize the fact that people judge all snowmobilers by my actions and will act accordingly and responsibly.

It will provide you with a vital link to others enjoying your sport.

It will mean the continuance of a high quality snowmobile program of trails and education.

It will keep you informed through its newspaper (published seven times a year) of matters of interest to snowmobilers

It will assist you in forming a snowmobile club or in preparing a local trail system.

The Oregon State Snowmobile Association is striving to protect your right to snowmobile. The combined efforts of all snowmobilers in Oregon are essential to achieve common goals. **There is strength in numbers, which is the one language our elected officials in Oregon and Washington, D.C. understand.**

Thousands of acres of snowmobiling have been lost in the West to the wilderness movement in past years, and thousands more will be lost this year and next if we don't act now! Don't just put gas and oil in your machine – the land we lose may be your favorite snowmobile area!

OSSA is working hard to provide vital economic information and assistance to all members of the Oregon legislature. We encourage the support of snowmobile clubs to promote goodwill and publicity for the nation's largest winter recreational sport.

What would be expected of me as a member of OSSA?

OSSA asks only that you please

be a responsible snowmobiler,

observe snowmobile laws, (license your machines),

assist in the **preservation** and **promotion of our sport** by attending, when possible, local public hearings which could affect snowmobiling,

provide OSSA with **news** of your club,

share your **ideas** and **enthusiasm** with others,

pay your annual dues,

be involved with OSSA and local clubs

Join us! The OSSA is an all-volunteer organization. **We depend** on each other to keep our sport enjoyable. **However, if you are unable to volunteer your time, your dues are an important part to keep OSSA strong.**
