SAF brings students and farmworkers together to learn about each other's lives, share resources and skills, improve conditions for farmworkers, and build diverse coalitions working for social change.

Through the Into the Fields internship and Sowing Seeds for Change fellowship programs, 30 bilingual (Spanish/English) college students and recent graduates devoted their summer to farmworker justice, reaching over 5,000 farmworkers and their families in NC, SC, and VA. Through outreach to farmworker families, students conducted health assessments, transported workers to clinic appointments, provided know-your-rights trainings, recruited migrant students, taught ESL classes, as well as educated the public through blogs and presentations. The students also participated in SAF's theater group focused on stress reduction and conducted a documentary project with workers about community.

SAF's From the Ground Up Program gathered workers' stories, educated the public, and advocated for change through a 20-year anniversary exhibit, an alumni documentary award, alumni socials, the NC Farmworker Institute summit and networking event, the Harvest of Dignity campaign, and presentations to the community. Through our Student Organizing School, eight NC college students were trained on how to organize on their campuses, coordinating presentations and events for more than 300 young people. 40 national and international partnering organizations participated in SAF's 14th annual National Farmworker Awareness Week from March 24-31, 2013 through over 500 events in 20 states reaching over 66,000 new allies.

Twelve farmworker youth came together through SAF's Levante Leadership Institute to discuss issues affecting their communities and to develop their leadership. The youth created our beautiful "Farmworkers Feed the World" portable fabric mural, reflecting their experiences working in the fields and SAF's work in the farmworker movement. Through the Let's Learn NC campaign, members of the Adelante Education Coalition promoted education equity through actions, events, presentations, and social media.
