programs are focused on the pharmacy community, it is reasonable that the Board of the Foundation come from and are elected by Pharmacists. In addition, as pharmacists, the Board has the specialized knowledge needed to administer the programs sponsored by the Foundation. The Board members come from a geographically dispersed area around the State of Georgia and thus represent a broad cross-section of the views and interests of those served by the Foundation.

(4) The IRS Regulations contain a series of provisions not applicable to the Foundation because the Foundation is not an organization of a type that generally provides facilities or services directly for the benefit of the general public on a continuing basis, the Foundation is not an educational or research institution, and the nature of the Foundation's activities and support are different from the nature of the organizations described in these sections.
