Mission: To build and sustain a health care workforce for the communities in the Three Rivers AHEC region.

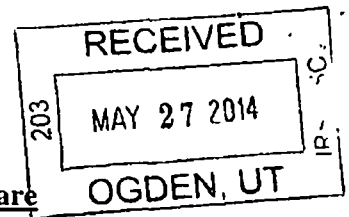
Values and Guiding Principles:

RECRUIT- Preparing Students for Careers in Health Care

- The *Chart the Course Academy* was developed to assist high school seniors in planning their route to a health career and staying on course! Since 2007, we have awarded \$25,075 in scholarships to 108 students who have successfully completed the Academy and Youth Volunteer Programs.

Chart the Course Academy-Three Rivers AHEC and Health Occupation Students of America (HOSA)

Thirty-three students participated in the 2012-13 *Academy*, and 11 were awarded scholarships to assist them as they pursue their health career education – five \$500, five \$200, and one \$25. The students participated in our seventh *Chart the Course Academy* which partnered with the HOSA Chapters at four high schools: Hardaway, Kendrick, and Northside in Muscogee County and Harris County High School. The students completed a year-long portfolio which required a minimum of 20 hours of HOSA service and activities – 1,505 total service hours were completed for an average of 45 hours per student! One of the activities included a field trip to Mercer University in Atlanta to visit the Physician Assistant, Pharmacy, and Physical Therapy programs. The students took home with them a great understanding of Mercer's culture of team learning, detailed information about the three programs, and interest in some of these opportunities. We are forever grateful for our partners who assist us with sharing these opportunities with our future health care professionals!

Where are they now? We have nurses and certified nursing assistants who are now practicing in hospitals and other health care offices. We have one scholar who is in medical school at Georgia Regents University. And the more recent scholars are still in the academic stage of their career.

- ***MedVac Summer Camp*** We partnered with the Medical Center of Central Georgia in Macon for the 2013 MedVac Camp summer youth health careers camp. Forty middle and high students participated and, represented 13 schools from 9 counties. Throughout the 5 days, the campers learned about the various health career opportunities through career presentations and tours at the Medical Center of Central Georgia. Mercer University's Public Health Masters Program students prepared a mixture of activities to raise the awareness of public health. A city-wide disaster drill was conducted at the Middle Georgia Regional Airport which gave the students an up close and personal experience from the first responders point of view. The final activity was a visit to the Bodies Exhibition in Atlanta. The students were amazed to see how the bodies were preserved and displayed to show the complexity of the anatomy of the human body.
- ***Taylor County High School Viking Academy*** One of our goals this year was to develop an academy program for one of our high schools in a rural county that does not have a HOSA chapter – the true spirit of helping a community "grow their own" The *Viking Academy* was designed to immerse the students into the world of health professions through classroom presentations, video modules and classroom assignments for a full semester. Forty-three students began this journey and will complete it by Christmas break. Updates and reports will be in our newsletter, *The Current*.
- ***Columbus State University's Competitive Premedical Studies Program*** Another goal we had this year was to become involved in an undergraduate health profession program to further strengthen our health career awareness programs by being involved at the next level of the students' education. By collaborating with this initiative, we are accomplishing this. Our missions are parallel and the program's intent is to help position more students on a successful path to medical school, thus addressing the physician shortage in Georgia. The Program kicked off September 2013 – updates and reports will be in our newsletter, *The Current*.
- **Other health career awareness Activities:** Conducted 73 health career awareness programs (classroom presentations, career days/fairs, and career counseling) reaching 3,499 middle and high school students. The breakdown consisted of 63% minority, 52% disadvantaged, and 38% both minority and disadvantaged from 12 of our counties (7 rural).

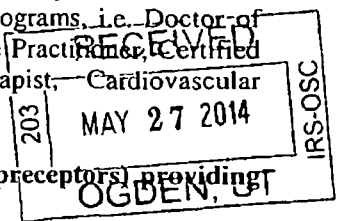
**TRAIN - Facilitating community-based clinical training experiences
for health professions students**

- **The Anchor: Clinical Training in West Central Georgia** was created in collaboration with the GA Campus-Philadelphia College of Osteopathic Medicine (PCOM) and the hospitals and health care providers in our region. The project is based on data that suggests that students who spend an extended period of time in an off-campus clinical training location will be more likely to choose that area for practice upon completion of their education. Since our June 2009 inaugural class, we have had 58 students enrolled in the Anchor program. Our first Anchor class is now in their third year of residency. We wait with anticipation for those who will return and practice in our region and Georgia.
- The mission of the **Good Shepherd Healthcare Clinic** is to meet the physical, social, emotional and spiritual needs of the medically underserved of greater Columbus and Chattahoochee Valley area. They accomplish this with a caring, selfless team of volunteer physicians and support staff. With a growing patient base of over 1000, the clinic is often not able to schedule new patients to see a physician in a timely manner. These patients, who call this Clinic their medical home, have no medical insurance or the necessary funds to cover initial doctor visits and other medical needs.

For the third year, Three Rivers AHEC teamed up with Good Shepherd for two "Outreach" Clinics to see 174 patients. Without these events, the patients may have waited four to six months for an appointment with a health care provider. Students from the **Mercer University Physician Assistant program**, the **Anchor programs**, and the **Columbus Technical College Practical Nursing and Medical Assisting program** joined Good Shepherd's volunteer physicians and other volunteers in treating these patients at absolutely no charge. Medications were prescribed from the discount and flat rate lists from various pharmacies in the community. **St. Francis Hospital** made arrangements for free or reduced cost imaging and lab services, and samples of medicines and supplies were donated and distributed.

This was a fantastic opportunity to contribute to the well-being and health of friends and family of our community. It was also a meaningful service learning experience for the students and an opportunity to boost the morale and productivity of the Good Shepherd Healthcare Clinic.

- **Coordinated 483 clinical training rotations in 19 of our counties.**
 - 13 (68%) of these counties are designated as rural or Primary Care HPSA (Health Professional Shortage Areas) and 6 of the counties have census tracts that are designated as Primary Care HPSAs.
 - Students performing clinical rotations were from health professions degree programs, i.e. Doctor of Osteopathic Medicine, Doctor of Medicine, Dentist, Physician Assistant, Nurse Practitioner, Certified Registered Nurse Anesthetist, Physical Therapist, Occupational Therapist, Cardiovascular Technologist, and Registered Nurse, representing 22 universities and colleges
- **Enlisted 174 health care providers who served as volunteer community faculty (preceptors) providing 81,259 training hours.**
 - Of the 271 students trained, 40% were minority and 21% were from a disadvantaged background.
- **Provided housing or travel support for 230 student rotations valued at \$77,623.**
 - A majority of the clinical rotations in our rural, medically underserved or HPSA counties requires students to leave their school/home base for a clinical rotation. The distance is too far for them to commute daily and thus can be a barrier preventing the student from being trained and thus exposed to the needs in these areas. Where we do not have student housing, we provide a travel support payment to help offset travel expenses. With the continued support from the 2013 General Assembly, we have funding to assist us in this important support area. Currently, we provide student housing in Columbus, LaGrange, and Covington.



RETAIN - Retaining Practitioners in the Community

- Three Rivers AHEC is dedicated to providing a comprehensive selection of continuing education courses designed to cultivate learning and enrich the lives of health care providers in our region and throughout the state of Georgia. In addition, we recognize our responsibility to assist healthcare professionals seeking to expand their knowledge and skills on a continuum, increase their competency, and maintain professional licensure and certification by providing appropriate educational course information. A combination of face-to-face conferences, live broadcast webinars, and on-demand online training are utilized to meet the training needs of these health care providers. For our webinars and online trainings, we partnered with **HealthTec^{dl}** which is a statewide distance learning program designed to support health professionals and strengthen services provided by nonprofit health organizations in Georgia.
 - The four face-to-face conferences focused on patient care in the fields of gastroenterology, orthopaedic nursing, and stroke. The webinar and on-demand training video modules focused on patient care in the fields of asthma, cancer survivorship, and diabetes.
 - A total of 801 nurses, physicians, physician assistants, and physical therapists were trained with 98% of them needing this training for continued licensure, certification, and/or employment. The average evaluation of these programs was 4.84 on a scale of 1 to 5 with 5 being excellent. A total of 2,270 continuing education contact hours were awarded.

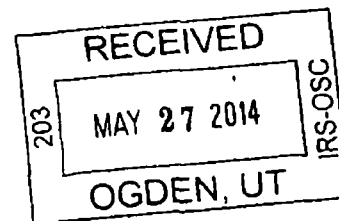
- **RN Reentry Program**

The academic institutions are educating, training, and producing quality nurses as quickly as possible, however, the forecast is there will still be a shortage of this critical member of the healthcare team! In Georgia, it is predicted that 24,000 RNs will be needed in the health care arena by the year 2018. (Source: Georgia Workforce Trends An Analysis of Long-term Employment Projections, to 2018; Published by the Georgia Department of Labor - Workforce Information & Analysis Division).

This RN Re-entry Program has been approved by the Georgia Board of Nursing to provide the individualized combination of 40 hours of study relevant to nursing and 160 hours of supervised nursing practice required by the Board for reinstatement of licensure as a registered professional nurse. This program has been designed for those nurses who are presently ineligible for reinstatement of their license because the license has lapsed or has been inactive. Nurses who have active licenses returning to direct patient care who have not worked in the clinical area for some time may also benefit from this program.

Since the program's inception (February, 2010), 15 RNs have been trained and transitioned back into the workforce. This is an excellent recruiting program for the training sites and a great way for them to "grow their own". The following 13 sites have been developed for the supervised nursing practice portion of the program:
