Schedule A, Part III - CHANGE IN ACCOUNTING PRINCIPLE IN 2011 (FISCAL YEARS ENDING AUGUST 31, 2012 AND THEREAFTER)

Effective September 1, 2011, Blessings International (the "Ministry") changed its method of valuing pharmaceutical inventory products to the lower of cost or market, with cost determined by a weighted moving average cost method. The cost of pharmaceutical inventory products was determined from the actual purchase costs of the products, including freight and any customs fees and duties, as well as an allocation of processing costs of bulk-purchased imported products from overseas suppliers.

In 2010 and previous fiscal years, the Ministry had recorded pharmaceutical products acquired by either purchase or gifts-in-kind (GIK) donations at their estimated average wholesale price (AWP) or the AWP of substantially equivalent products obtained from the Thomson Reuters "Red Book", whose AWP's were meant to approximate wholesale prices in the United States. The Ministry treated purchased pharmaceuticals as equivalent to GIK donations, as the Ministry was able to purchase pharmaceuticals at significantly discounted prices far below their AWP values, and recorded both purchased and donated pharmaceuticals in accordance with nonprofit industry standards referred to as the Interagency GIK Standards. Due to a revision in the Interagency GIK Standards in December 2009, it became impractical for the Ministry to comply with the requirements for determining estimated fair values, as the majority of the value of the Ministry's hundreds of pharmaceutical products was represented by products that were not legally permissible to be sold in the United States, and such products would now have to be valued using estimated wholesale prices determined from an undeterminable number of foreign exit markets. Due to the fact that all the Ministry's pharmaceutical products had been acquired solely by purchase since 2009, management of the Ministry determined that a change to the cost method of valuing its pharmaceutical products was in order as preferable, since it utilizes a conservative and objectively verifiable measure of the value of the Ministry's pharmaceutical products distributed to user organizations. The use of the cost method also aligns the financial reporting of purchased pharmaceuticals with other nonprofits, although Blessings International is unique in that it relies solely on purchased pharmaceuticals to achieve its program services goals, while the vast majority of all other nonprofits primarily utilize GIK donations of pharmaceuticals.

Line 16b - FUND-RAISING EXPENSES

The Ministry's fund-raising efforts consist of annual participation in the Combined Federal and State Campaigns, as well as occasional newsletter appeals and special events. The Ministry's fund-raising efforts through normal operations consist of the allocated portion of the salaries and related overhead of the Ministry's President, Development Director, Executive and Administrative Assistants and others, and certain identifiable costs related to fund-raising, including consulting services and advertisements for cash donations placed in various publications. Such identifiable fund-raising expenses were \$41,345 for the fiscal year ended August 31, 2013.

Part III Statement of Program Service Accomplishments:

Consistent with the above mission statement, Blessings International provided the following program services:

- A. Relief and development programs directed by Blessings International and by collaboration with other organizations: This includes specific programs designed to supply pharmaceuticals and medical supplies for relief and development efforts following national disasters, wars or various types of armed conflict, as well as in developing nations struggling to improve basic medical services.
Program Service Expense: \$23,738.
- B. Haiti relief programs funded in part by Blessings International in collaboration with indigenous ministries: Blessings International continues its commitment to help Haiti long after the acute recovery phase of the January 2010 earthquake and the effects of Hurricane Sandy. Blessings has been equipping indigenous ministries with vitamins, antibiotics, antimalarials, analgesics and antiparasitic drugs, in addition to medicines for chronic diseases such as arthritis, hypertension, gastric reflux, asthma and diabetes. Thereby, Blessings is making it possible for 19 permanent clinics to have adequate supplies of vitally important medicines for this prolonged rebuilding and rehabilitation phase of disaster relief.
Program Service Expense: \$44,923.
- C. Medicines for short-term medical teams: This is Blessings' major mission, to provide pharmaceuticals and medical supplies to short-term medical teams visiting developing nations who, in turn, serve indigent children and adults suffering from various diseases and illnesses. These teams are organized by ministries and churches that are independent of Blessings International.
Program Service Expense: \$2,932,324.
- D. Democratic Republic of Congo: The eastern part of the Democratic Republic of the Congo (DRC) is one of the most unstable, war-torn places on earth. Some 4.5 million people have died since fighting began in 1998, and the eastern part of the nation remains the most unstable and dangerous part of the nation. This summer Blessings International was contacted by a Methodist doctor who runs a number of medical clinics in that part of the DRC who requested assistance in obtaining pharmaceuticals. In

response, Blessings was able to donate two pallets of medicines to the DRC.

Program Service Expense: \$16,401.

E. USA indigent care: This program supplied purchased medicines for indigents and the working poor that were treated through non-profit and church-based clinics in the USA. Blessings received cash donations that allowed for major discounts spread among all the U.S. clinics Blessings serves. In this way, Blessings International has spread the blessing of these gifts to include very small as well as very large clinics. This year, Blessings served 34 U.S. clinics and outreaches operated by Christian/charitable organizations in 16 states. Even though the total value of shipments to U.S. clinics is less than 1% of the value of all shipments, Blessings International is committed especially to helping the working poor of this nation. Blessings will continue to help the many U.S. clinics working to fill the urgent need of providing medical care to the least fortunate among us.

Program Service Expense: \$33,216.
