Substance Abuse Prevention - Provided a proven, evidence-based curriculum to youth in Kindergarten through 12th grades in 8 counties The program's goal is to increase knowledge about the dangers of substance use and abuse and to provide the youth with the skills they need to make good choices for their lives For FY13, our prevention program served 13,368 youth across the 8 counties served and through extensive evaluation, 97% of the participants were able to complete the 10 to 12 week program, and 89% of those youth displayed an increase in knowledge regarding substance use and abuse and a change in their pro-social behaviors We were also able to provide information, through 1,277 individual presentations apart from the prevention curriculum, on the dangers of alcohol, tobacco and other drugs to 29,194 youth and adults
