Vineyard Early Childhood Center achieved the following: (1) became certified as a Head Start program for one classroom of 20 pre-kindergarten children; (2) augmented outdoor playground facility for toddlers through in-kind donation from United Way of Central Ohio; (3) continued "One Star" quality rating through Ohio's "Step Up To Quality" program, which recognizes excellence in early childhood education programs ("Three Star" rating is highest level); (4) maintained at 54% the percentage of enrolled children from low- to moderate-income families (measured by eligibility for Title XX), reflecting continued diversity of families served; and (5) maintained six all-day classrooms for ages six weeks to five years (plus half-day pre-school during academic year) and, against licensed capacity of 104 children per day, had average daily attendance of 101.7 (0.6% increase).

4b (Code:) (Expenses \$ 384,417.08 including grants of \$ 0.00) (Revenue \$ 91,697.92)

The Organization's after-school and summer programming for school-age children, called "The Zone" for grades K through 8 and "LAUNCH" for grades 9 through 12, achieved the following: (1) the Director of the Organization's early childhood center, who has been in that position since the Organization's founding, agreed to become the Organization's Director of Youth Education, thereby adding direct oversight of The Zone and LAUNCH to her continuing direct oversight of Vineyard Early Childhood Center; (2) the Zone Summer Program's enrollment was reduced to a cap of 250 children in order to make better, more focused use of the facility and to increase the level of attention and care available to each child (previous summers' enrollment figures were typically in the range of 425 to 475 children); (3) LAUNCH: Life-Readiness for High School Students completed its second academic year with average daily attendance of 10 students and two volunteers (in addition to one paid staff member); and (4) average daily attendance in The Zone After-School Program was 76.3 children (a 13% increase over the prior academic year).

The Organization's Social Outreach Programs achieved the following: (1) added a part-time immigration services counselor (to support the Organization's full-time accredited immigration counselor) due to the volume of cases to be handled (pursuant to authorization granted in 2011 by the U.S. Department of Justice, Executive Office for Immigration Review, Board of Immigration Appeals); (2) average number of programs/classes offered per month increased from 53.7 to 59.4 (11%); (3) average attendance at classes and programs increased from 2,521 per month to 3,004 per month (19%); and (4) volunteers-in-service per month decreased from 111.9 to 98.5 (12%).

Form 990, Part III, Line 3: Beginning in 2009, the Organization's sister corporation, Vineyard Church of Columbus, initiated "Recession Response" services focused on coordination of benefits for those being impacted by the Great Recession, assisting those who had lost their jobs with finding new employment, and providing financial counseling and education. The Organization assumed responsibility for these services on Sept. 1, 2011, with continued funding provided by Vineyard Church of Columbus. The special funding, which was originally planned to stop in Spring 2012, was extended until August 31, 2013. Prior to that date, the Financial Specialist position was re-absorbed by Vineyard Church of Columbus (effective Sept. 1, 2012), and the In-Take & Care Coordinator position was discontinued when the person in that role took another position (effective July 1, 2013). The Employment Specialist position was discontinued as of August 31, 2013. The Organization continues to offer career counseling and financial counseling/education programs through volunteers.

Form 990, Part III, Line 4d: The Organization's Sports & Exercise Programs (expenses=\$215,352.07; revenue derived directly from activity=\$103,272.34) achieved the following: (1) the Organization had a full-time Director of Sports & Exercise Programs and a full-time Assistant Director, the latter of whom was trained to replace the former, who spent Summer 2013 phasing out and preparing to re-locate to another city (the Organization elected not to "back fill" the newly vacated Assistant Director position, leaving just one full-time staff member); (2) average monthly participation decreased from 4,329 to 3,850 (11%); and (3) average programs in operation per month remained steady at 22.

The Organization's Free Health Clinics (expenses=\$159,970.53; revenue derived directly from activity=\$0.00) achieved the following: (1) full-time Director of Health Clinics re-located with family to a different city on May 3, and the Organization chose to defer hiring a replacement pending study of the potential impact of the Affordable Care Act on the operation of free clinics and the potential for collaboration with other clinics; (2) at its inner-city location (Weinland Park), treated 251 medical cases, 442 dental cases, and 99 vision cases (all patients were uninsured with income at or below 200% of the federal poverty guideline), a total of 792 cases, representing a 6% decrease; (3) at its on-site location, treated 175 medical cases, 364 dental cases, 172 chiropractic cases, and 73 vision cases (all patients were uninsured with income at or below 200% of the federal poverty guideline), a total of 784 cases, representing a 2% decrease; and (4) averaged 125 volunteers-in-service per month (2% increase over prior year).

employees of Vineyard Columbus to fill the Organization's staffing needs. Accordingly, although the Organization directly employs nobody, the Organization does reimburse Vineyard Columbus for all Personnel Expense incurred by Vineyard Columbus in connection with the employment of staff provided by Vineyard Columbus to the Organization. The Organization records such reimbursement as Personnel Expense, but Vineyard Columbus, as the direct employer of such staff, is responsible for all reports and filings required by the IRS and any other federal, state, and local authorities related to such employment.

Form 990, Part VI, Line 7a: The Organization and Vineyard Columbus are related as follows: (1) the Organization is organized and operated exclusively to carry out the purposes and mission of Vineyard Columbus; (2) the Organization is controlled and managed by its Board of Directors, the members of which must be nominated by the Senior Pastor of Vineyard Columbus and confirmed by a majority of the members of Vineyard Columbus' "senior pastoral team" (i.e., its senior management team); and (3) the Organization's officers are elected by its Board of Directors, but the Organization's President must be either the Senior Pastor or the Executive Pastor of Vineyard Columbus.

Form 990, Part VI, Line 7b: The following matters are subject to the approval of the Senior Pastor of Vineyard Columbus and a majority of the members of Vineyard Columbus' "senior pastoral team" (i.e., its senior management team): (1) amendment of the Organization's articles of incorporation; (2) amendment of the Organization's code of regulations; and (3) removal from office of the President of the Organization.

Form 990, Part VI, Line 11b: The Organization's Form 990 is prepared internally by the Organization's Executive Director (who is also the Organization's Treasurer), after which the Organization's Board of Directors meets to review the prepared Form 990 prior to its filing. Prior to the board meeting, each board member is given a paper copy of the narrative portions of the prepared Form 990 to review in advance. At the board meeting: (1) each board member is given a paper copy of the prepared Form 990; (2) any questions or concerns resulting from the board members' respective reviews of the narrative portions of the Form 990 are discussed and resolved to the satisfaction of the board; (3) the Organization's Executive Director orally presents to the board a summary of the financial information presented on the Form 990 (it being the case that each board member is familiar with the Organization's financial statements and financial position in advance of the preparation of the Form 990); and (4) the Form 990 is not filed until any questions or concerns raised during the board meeting are resolved to the satisfaction of the board (even if such resolution requires subsequent meetings of the board).

Form 990, Part VI, Line 12c: Persons covered by the Organization's Conflict of Interest policy are its directors and officers, as well as its Director of LAUNCH: Life-Readiness for High Schoolers, Director of "The Zone" After-School & Summer Program, Director of Vineyard Early Childhood Center, Director of Sports & Exercise Programs, and Director of Vineyard Free Health Clinics. The Executive Director of the Organization personally interviews each of these individuals annually to discuss whether or not each individual has any financial interest that could constitute a conflict of interest. The Secretary of the Organization personally interviews the Executive Director annually for the same purpose. If there arises any financial interest on the part of one of these covered persons that may constitute a conflict of interest, the per-

son with the interest is given the opportunity to present all material facts to the Organization's Board of Directors. All disinterested board members then consider the financial interest and the material facts and determine if a conflict of interest exists. Any covered person with a conflict of interest is prohibited from participating in any deliberation or decision as to any conflict of interest transaction.

Form 990, Part VI, Lines 15a and 15b: The process for determining compensation (as described below) is undertaken annually, was last undertaken in Summer 2013 following annual performance reviews (a mid-year event), and is used for all full-time positions of

Vineyard Columbus and the Organization, including the Organization's top co-management officials (the positions of Executive Director and Pastoral Director). The process is as follows: Written annual performance appraisals are completed by the supervisor with input from self-reviews and "360-degree" reviews by subordinates and key volunteers. All appraisals are reviewed, compared and evaluated by a Salary Review Committee (the "SRC"), which is appointed by and under the jurisdiction of the Vineyard Columbus Church Council (i.e., its Board of Directors). The SRC is made up of Vineyard Columbus church members who are financially disinterested and independent of Vineyard

Columbus staff, as required by Vineyard Columbus' code of regulations. The SRC's review includes the use of multiple national comparative salary reviews for churches (which are obtained by the Vineyard Columbus human resource department and provided to the SRC), with all positions classified into comparative salary ranges. Based on a target average merit percentage established by the Vineyard Columbus "senior pastoral team" (i.e., its senior management team), the employee's performance, and the employee's current salary location within the predetermined salary range for the employee's position, the SRC, through a joint deliberative process that is contemporaneously substantiated, determines and recommends adjustments for each employee. The SRC's recommendations are communicated in writing in the form of a spread sheet that the SRC compiles over the course of its deliberations and gives to the Vineyard Columbus Senior Pastor, Executive Pastor, and human resources department. As required by Vineyard Columbus' code of regulations, the SRC's recommended adjustments are binding as to members of the "senior pastoral team." For all other positions (including the Organization's Executive Director and Pastoral Director), the Vineyard Columbus Senior Pastor and Executive Pastor review and approve in writing the spreadsheet provided by the SRC. Any changes to the SRC recommendations desired by the Senior Pastor or Executive Pastor do not become effective until they have been presented to the SRC and resolved by mutual agreement. All such discussions and decisions are contemporaneously substantiated.

Form 990, Part VI, Line 19: The Organization does not yet post any of its governing documents, its conflict of interest policy, or its financial statements on the Organization's website. Copies of these documents are available upon request (although, as of the date of filing of this Form 990, the Organization has received no such requests).
