HAD THE EXTENSIONS BEEN TIMELY FILED, THIS FORM 990 WOULD HAVE BEEN PROPERLY FILED WITHIN THE 10 1/2 MONTHS ALLOWED AFTER YEAR-END. THE ORGANIZATION RESPECTIVELY REQUESTS THAT THE IRS CONSIDER REMOVING OR REDUCING LATE FILING PENALTIES.
