Biblical/Christian world view training: The McKenzie Study Center seeks to promote a clear understanding of the Christian gospel and its personal, social and cultural implications for todays people. This objective was pursued through classes, seminars, writing and counseling. Between 50-70 part-time students attended weekly classes each academic quarter, and approximately 20 people were in-house residents. Counseling and tutoring were performed, as well as processing of orders for instructional tapes and publications, and ten issues of a monthly newsletter addressing issues related to the Christian faith and world view were produced and sent to approximately 2,200 individual and church subscribers. Staff also regularly taught in churches both locally and outside the area.

The purpose of Art Project is to promote an integration of the biblical worldview and the arts.
