HOPE TECHNOLOGY SCHOOL:

Encouraged by the success of its Education Lab, Erudite Technology Group began work in 2000 to develop a full-inclusion model elementary school for children with and without special needs, capitalizing on best practices in education and technology. Work to develop the school continued in 2001 and culminated in its official opening in September 2001. The school is called Hope Technology School (HTS) and has expanded to include programs for children from preschool through middle school and beyond. After more than a decade, HTS continues to fulfill its purpose of providing first class education to all children, but particularly to special needs children, with dignity and acceptance.

During the September 1, 2012 - August 31, 2013 school year, HTS served 102 students in Kindergarten through eighth grade, 18 students in the pre-school and 4 students in our VocEd program
