Workforce Services Programs Eastern Maine Development Corporation provided job training services to low income adults and youth, migrant seasonal farmworkers, dislocated workers and other targeted job seeker groups through a variety of federally funded programs during fiscal year 2013 These services are delivered at no cost to participants who meet the eligibility criteria

Business Lending Program Eastern Maine Development Corporations (EMDC)Lending Division is designed to provide existing or startup businesses with special financing needs Its objective is to create quality job opportunities and stimulate economic activity EMDCs role as a secondary lender is to work with banks and other private and public funding groups to leverage the capital available to small businesses EMDC has several secondary loan funds to finance a wide variety of business needs, including equipment, real estate and working capital Through our lending programs, EMDC offers direct loans of \$1,000 to \$4,000,000, creatively packaged with partners in the banking and investment communities Since the inception of the program in the early 1980s, EMDC has disbursed nearly \$72 million to over 550 companies, leveraging nearly \$247 million in other private and public funds Over 10,855 jobs have been created or retained EMDC currently has approximately \$15,942,000 in loan funds outstanding to 149 clients The Rural Microentrepreneur Assistance Program (RMAP) Sponsored by the U S Department of Agriculture, this program is designed to support the development and ongoing success of rural micro-entrepreneurs and microenterprises In 2011, EMDC was granted \$500,000 to make loans to eligible borrowers Some examples of eligible projects are Working capital, purchase of furniture, fixtures, supplies, inventory or equipment, debt refinancing, business acquisitions, purchase or lease of real estate that is already improved and will be used for the location of the subject business only (construction of any type is strictly prohibited) To date, EMDC has loaned \$515,400 to 17 businesses, with an additional \$543,100 in leveraged funds, which created or retained 70 jobs SBA 7a Community Advantage Loan ProgramIn 2011, Eastern Maine Development Corporation was accepted into a pilot initiative by the United States Small Business Administration (SBA) that has enabled us in assisting businesses to attain lower dollar loans in under-served communities The program includes a streamlined application process for loans providing loan decisions within five to ten business days As a result of its success with this program, EMDC has been able to offer loans to qualified individuals/organizations up to a maximum of \$250,000 The SBA guarantees 85% for loans up to \$150,000 and 75% for those greater than \$150,000 To date, EMDC has closed 25 loans totaling \$2,762,550, with an additional \$674,900 in leveraged funds, which have created or retained 50 jobs We have also been successful in selling these loans on the secondary market

Maine PTAC Program The Procurement Technical Assistance Program (PTAC) was set up under Title 10, United States Code, Chapter 142 in Maine PTAC is a statewide program which offers procurement technical assistance services to Maine Businesses on issues related to government contracting Currently, it serves 605 businesses that have requested assistance During 2013, Maine PTAC sponsored 20 outreach events including training workshops and participated in 12 non-sponsored outreach events The program also provides a Bid Match service to clients and supplies them with relevant information about government contracting through newsletters, online training and a website www.maineptac.org Clients assisted by the Maine PTAC have reported over 461 government prime contract awards valued over \$141 million and 226 sub contract awards worth over \$14 million during 2013
