These field trips are enrichment activities for the students that enhance their middle school experience. The PTO assists the teachers coordinating these educational experiences by depositing checks from students into the PTO account and issuing checks directly to the tour groups. The money collected for these trips were listed under "Other Income" on Form 990-EZ, Part I as advised by the IRS. For Schedule A, Part III, these funds were included in Line 2 rather than Line 12 since the funds were directly related to Public Support. These funds directly related to the tax-exempt purpose of enhancing the students' middle school experience.
