THEY INCLUDED OUR PARK THE PLOW PROGRAM THAT IMPACTED PRODUCERS WITH EDUCATIONAL PROGRAMS, EQUIPMENT DEMONSTRATIONS AND SUPPORTED THE WORK OF A STATE-WIDE PRODUCER GROUP. THE GRASS ROOTS PROJECT SUPPORTED ADOPTION OF PRESCRIBED GRAZING AND THE TRANSITION OF CROP LAND TO PASTURE AS WELL AS IMPROVED MANAGEMENT OF EXISTING PASTURE RESULTING IN REDUCED RUNOFF OF NITROGEN, PHOSPHORUS AND SEDIMENT. THE ASSISTANCE HAS IMPACTED 19 FARMS CONTROLLING 646 ACRES OF PASTURE LAND. THIS PROJECT WAS FUNDED IN 2013 BY THE PA DEPARTMENT OF ENVIRONMENTAL PROTECTION, THE FOUNDATION FOR PENNSYLVANIA WATERSHEDS AND NATIONAL FISH AND WILDLIFE FOUNDATION DURING THE FISCAL YEAR.
