PsychiatryLifespan is fully committed to integrating high quality mental health care with primary medical services LPG physicians in psychiatry, who transferred to LPG in June 2013 from RIH and TMH, offer behavioral medicine services to help individuals improve health through behavior change Inpatient services include assessment and treatment of acutely ill patients requiring a secure, safe environment for treatment of the full range of psychiatric problems, including psychotic, mood, and geriatric disorders, as well as suicidality Care is also available for patients with co-morbid medical conditions, developmental disabilities, significant family disturbances, and for adults suffering from substance abuse (See Schedule O)

The pediatricians represent the largest group of physicians employed by LPG, and in fiscal year 2013 reflected \$4,678,245 of the total operating expenses of LPG, primarily payroll and fringe benefit expenses funded by RIH. Similarly, the Hospitalists of TMH accounted for \$915,757 of LPG's operating expenses and that funding was provided by TMH.
