During fiscal year 2013, Bradley Hospital Foundation transferred \$1,042,698 in funds raised to Emma Pendleton Bradley Hospital to support the expansion of the Outpatient Services Department, which has reached capacity as demand for services soars A new addition will allow the Outpatient Services Department to better serve the community by reaching more children and families in need of mental health care, as well as improving the quality and environment of that care The 2,284 square foot addition will include more space for group therapy which will allow the department to accommodate the increased patient volume

Through the development and administration of philanthropic activities, the Bradley Hospital Foundation is able to transfer various funds raised to Bradley Hospital to support its operating activities, which in turn benefit the Rhode Island community For example, \$67,885 was transferred for the Pediatric Partial Hospitalization Program Another, \$54,960 was used to improve primary health care for adults with autism Also, \$51,375 was provided in support of the Pediatric Mood Imaging Neuro Development program (PediMIND), which uses brain imaging techniques, including magnetic resonance imaging (MRI), behavioral measures, and genetic analyses to identify biological and behavioral markers (scans and tests) of psychiatric illness, including bipolar disorder, in children and adolescents

The Foundation's Capital Campaign helps defray Bradley Hospital's cost of expansion, construction, renovation, equipping and furnishing of a major two-story addition to its patient care/residential school facilities, as well as the renovation of existing space to expand Bradley Hospital's partial, residential, school and outpatient programs and its research studies The Bradley Hospital building, which opened 4/1/09, is helping to meet the rising demand for child and adolescent mental health services and enhance the overall quality of care for children and their families It has been designed to be a modern, state-of-the-art facility consisting of 60 private rooms that also provides a comfortable child-focused atmosphere that is essential to the care and therapy of patients The redesign allows Bradley Hospital staff to better monitor and respond more quickly to patients and their needs
