THE AUBURN RESEARCH AND TECHNOLOGY FOUNDATION IS AN INDEPENDENT ALABAMA NONPROFIT CORPORATION ORGANIZED TO DEVELOP AND OPERATE THE AUBURN RESEARCH PARK AND TO ASSIST AUBURN UNIVERSITY WITH THE ATTRACTION, DEVELOPMENT, AND COMMERCIALIZATION OF TECHNOLOGY. THE FOUNDATION'S ACTIVITIES ARE GOVERNED BY ITS OWN BOARD OF DIRECTORS. THE FIRST MAJOR PROJECT OF THE FOUNDATION WAS THE ESTABLISHMENT OF THE RESEARCH PARK. THE RESEARCH PARK IS THE RESULT OF A PARTNERSHIP AGREEMENT BETWEEN THE STATE OF ALABAMA THROUGH THE GOVERNOR'S OFFICE, AUBURN UNIVERSITY, THE CITY OF AUBURN, AND THE CITY OF AUBURN INDUSTRIAL DEVELOPMENT BOARD. THE VISION FOR THE PARK IS TO ESTABLISH AN ENTREPRENEURIAL ATMOSPHERE IN A BUSINESS AND RESEARCH ENVIRONMENT WHICH FOSTERS CREATIVITY AND INNOVATION, AND EMBRACES COLLABORATION, PARTNERSHIPS, AND NETWORKING THAT LEADS TO ECONOMIC DIVERSIFICATION AND ENHANCED ECONOMIC VITALITY OF THE UNIVERSITY AND THE LOCAL COMMUNITY, STATE AND REGION.
