Our mission is to prevent and end homelessness by uniting Manatee and Sarasota Counties through engagement and collaboration with business and civic leaders, service providers, faith-based organizations, advocates and people who are homeless or at-risk of homelessness.

 Continuum of Care Program (CoC): CoC activities are described in both Federal and State law, and require the lead agency to convene regular meetings to coordinate homeless services, provide education and find solutions to local homeless issues. Annually we develop a collaborative application to Housing and Urban Development (HUD) which this year brought \$766,768 directly to providers with no administrative charge. Every January, we coordinate a regional homeless census, which provides demographics on local homelessness, showing the complexity of the problem. We work closely with both Manatee and Sarasota county governments, cities and civic organizations. In the fall, we assisted Dr. Marbut with surveys and plan development for Sarasota. In addition, we work closely with Turning Points and the Manatee Coalition to secure additional grant funds to house the homeless. Outreach and education is achieved through public presentations, our website, e-newsletter, Facebook Page and Fact Sheets. We also distribute Resource Guides on homeless services throughout the community to help the homeless and at-risk locate services. 92% of the funds we receive go directly to program services.
 Note: the decrease in revenue for this year reflects the end of special stimulus funding that was passed through to providers for homeless prevention services.

4b (Code:) (Expenses \$ 175,287 including grants of \$) (Revenue \$)
 HMIS Program: The Homeless and at-risk Management Information System (HMIS) is a foundation for collaboration and delivery of services. Our program staff monitor the system activities, provide training for users, assist agencies with workflow design, run customized reports to support grant requirements, review data for quality and timeliness, provide help-desk support to users, and work closely with the HMIS Committee to develop policy and implement improvements. This program serves 15 provider agencies and supports over 150 users.

4c (Code:) (Expenses \$ 16,813 including grants of \$) (Revenue \$)
 HUD Housing Voucher Program. The Partnership developed this special HUD Housing Voucher Grant in collaboration with Manatee Glens, to provide housing for homeless individuals and families. Focused on chronically homeless individuals with mental health and substance abuse issues, this project targeted the most vulnerable and proved the need for intensive, ongoing supportive services for this population.
