Part I: Line 10 - Grants and similar accounts paid

The total spent on programs to support orphans and vulnerable children was \$69,940.

Of this, \$229 was spent on what we call "Level 1" support for 2 children. Their school fees, uniforms and materials were purchased so they could attend a local public school.

"Level 2" funding is for children who excel in school. They are part of an incentive-based program. We spent a total of \$16,502 for 29 students to attend school (this covered fees, materials and uniforms) and we spent an additional \$13,384 on extra lessons for children who needed support, special dinners and prizes for children who achieved high marks. "Level 3" funding is allocated for older students who attend skills based programs or technical schools. We spent \$13,911 for 8 students to learn trades. "Level 4" funding is for students in boarding school. We spent \$12,592 on 4 students to cover all their expenses. Finally, we spent \$10,909 for 5 "Level 5" students who are completing university level programs. General programming expenses that did not fall into any particular level amounted to \$2,413.

Part I: Line 16 - Other expenses

In total we spent \$4474 on administrative expenses. These include bank fees, office supplies, website maintenance and fees to the Attorney General office for filing annual reports. Almost half of the \$4474 was spent on travel to and from Zimbabwe.

Amended 990-EZ: Part I - lines 1 and 9. The total raised was \$104,030 and not \$104,690.

Amended 990-EZ: Part I - line 18. This amount changed when line 9 changed. The correct amount is \$23,227, not \$23,887.

Amended 990-EZ: Part I - lines 19, 22a, 25a, 27a. This amount should have been taken directly from the previous year's taxes. The correct amount, which is also listed on the 2011 990-EZ line 27b is \$836, not \$1178.

Amended 990-EZ: Part I- line 21, 22b, 25b, and 27b. The amended number (\$24,063) reflects the amount that was in the bank at the end of our reporting year and will be carried over to the 2013 taxes. Also, I removed the \$175 from Part II, line 26 because that expense was already included in the year's spending.

The total gifts, grants and contributions for 2008-2012 were changed on the amended forms so all of Part II has been amended. The total raised in 5 years should be \$508,413 and not the \$509,467 originally submitted. The percentage of public support changed from 72% to 71% and the amount listed for the previous year has also been changed to reflect the amended 2011 taxes.
